ITEM NO. TITLE AND EXPLANATION

- 1-4 SELF-EXPLANATORY
- 5 CONTROL LANGUAGE. Leave blank, U.S. Army Human Resource Command use only.
- 6 SERVICE/AGENCY. Enter the individual's Service or Agency.
- 7 COMPONENT. Enter the individual's Service component, e.g., Active, ARNG, Reserves.
- 8 ORGANIZATION AND STATION. Enter individual's organization and station.
- 9 LANGUAGE. Enter the results of each language evaluated. Multiple skills for the same language evaluated on the same day can be entered on one line. If the skills for the same language are evaluated on different days, enter them on separate lines.
  - a - FOREIGN LANGUAGE. Enter the foreign language evaluated.
  - b - LANGUAGE CODE. Enter the language identification code for the foreign language evaluated.
